"Foreign enterprises in Indonesia have the same tax rights and obligations as other taxpayers (including local enterprises), namely calculating, paying, and self-reporting the tax owed. Referring to the currently applicable local tax law, foreign enterprises in Indonesia are subject to tax as stipulated in the Law of the Republic of Indonesia No. 36 of 2008, which is the fourth amendment to Law no. 7 of 1983 concerning Income Tax. The Italian Embassy in Jakarta is organizing in partnership with IBAI a roundtable discussion aimed at giving the opportunity to the Italian enterprises in Indonesia to share their experiences, difficulties and good practices on tax management."

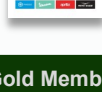
