The Extension of Domestic Travel Provisions during Corona Virus Disease 2019 (COVID-19) Pandemic.

On January 9th 2021, the National Task Force for Handling COVID-19 issued Circular Letter (SE) No. 7 Year 2021 concerning on the Extension of Travel Provisions for Domestic People during the Corona Virus Disease 2019 (COVID-19) Pandemic.

This Circular Letter is motivated by the high level of transmission of COVID-19 in Indonesia's territory, marked by the positivity rate, active cases, and the addition of positive cases at the national level. In addition, CL National Task Force No. 5 Year 2021 concerningon the Provisions for the Travel of Domestic People During the COVID-19 Pandemic that also ended on February 8th 2021.

These travel provisions for persons were prepared with the intention of extending the validity period of the application of health protocols for domestic people traveling during the COVID-19 pandemic. The aim is to increase the application of health protocols in new habits for the creation of a productive and safe life for COVID-19; prevent an increase in the transmission of COVID-19; and limiting land long-distance travelers and using the train mode during long holidays or religious holidays.

In the signed CL, the domestic travelers must follow a number of provisions. Among these provisions, every individual traveling by private or public vehicle is responsible for their own health and is subject to and obeying the applicable terms and conditions. For trips to Bali, there are numbers of condition applied, such as the following:

- 1. Travelers using air transportation are required to show a negative RT-PCR result certificate. The sample of which is taken within a maximum period of 2 x 24 hours prior to travel requirements.
- 2. Fill out the Indonesian e-HAC online
- 3. Meanwhile, travelers using land or sea transportation are required to show negative RT-PCR test results or negative rapid antigen tests, the samples of which are taken a maximum of 3 x 24 hours before leaving.

This CL also referred **for travel to and from Java Island** as well as travel between provinces / regencies / cities in Java Island. Travelers**who use land public transportation** are randomly tested by a rapid test or GeNose test if needed by the Covid-19 Task Force withinthe area.
