The update on Foreign Trade Statistical Imports per May 2021 by Central Bureau of Statistics

On Aug 9th, 2021 the Central Bureau of Statistics (Badan Pusat Statistik/BPS) has released the data of Foreign Trade Statistical Imports for updated to May 2021. It is stated that the imports value has reached USD 14.234,80 million, or down to USD 1.969,50 million (12,15%) compared to the previous month. In aggregate, there was also a decrease in import volume by 14.590,50 thousand tons (5,01%). The import value in May 2021 alone consisted of oil and gas for USD 2.061,90 million (14,48%) and non-oil and gas for USD 12.172,90 million (85,52%). By that, the oil and gas imports have reached 3.627,40 thousand tons (24,86%) and non-oil and gas 10.963,10 thousand tons (75,14%).

Cumulatively, the value of Indonesia's imports during January-May 2021 has increased by USD 13.678,60 million (22,74%) compared to the same period the previous year. The increase was influenced by the increase in the value of oil and gas imports of USD 2.367,50 million (34,55%) and non-oil and gas of USD 11.311,10 million (21,23%). Judging from the proportion, the value of non-oil and gas imports during the January-May period from 2017 to 2021 dominates Indonesia's imports with an average of around 86,37% per period.

Moreover, during January-May 2021, the loading port in DKI Jakarta has the highest contribution to Indonesia's import trade transactions reaching USD 36.228,60 million or accounts for 49,08% of Indonesia's total imports. Several provinces with high import contribution include; East Java with USD 10.452,70 million (14,16%), Riau Islands with USD 6.207,60 million (8,41%), Banten with USD 5.787,20 million (7,84%), Central Java with USD 4.361,30 million (5.91%), and the contribution of other provinces is relatively below 5,00%. Compared to the same period last year, the import value of ten main provinces during January-May 2021 increased, including DKI Jakarta (18,08%), East Java (22,99%), Riau Islands (36,16 %), Banten (39,71%), and Central Java (8,10%).

Based on country groups, the largest imports during January-May 2021 was from the APEC group countries with USD 36.799,40 million (49,85%), followed by ASEAN with USD 15.460,40 million (20,94%), NAFTA with USD 5.000,70 million (6,77%), the European Union USD 4.083,80 million (5,53%), and other groups of countries contributed USD 12.477,20 million (16,91%). The role of imports of European Union countries was dominated by Germany at 29,82% of the total value of EU imports, and Italy in the second ranks with 18,64%, followed by France 12,54%, the Netherlands 8,21%, and Belgium 5,44%.
