The Announcement of the Second Dose Booster of COVID-19 Vaccination Based on the Ministry of Health Circular Letter No. HK.02.02/C/380/2023

On 20 January 2023, the Ministry of Health issued Circular Letter No. HK.02.02/C/380/2023 concerning the Second Booster Dosage Covid- 19 Vaccination for the Group General Community due to the mutation of a new variant of COVID-19. This Circular Letter is intended to increase support and cooperation with local government and healthcare facilities providing immunization services, both government and private sector, in carrying out the second booster of COVID-19 vaccination. This vaccination program is applied to the general public that included Indonesian citizens and foreigners domiciled in Indonesia aged 18 years and above.

The second booster dose of the COVID-19 vaccination can be carried out at the COVID-19 vaccination service post and is given at intervals of 6 (six) months after the 1st booster dose of vaccination. The application of the second dose of vaccine has been approved by the Emergency Use Authorization (EUA) from the Food and Drug Supervisory Agency (BPOM) with the list of vaccines in the table as follows:
