Update Regulation of COVID-19 Response Acceleration Task Force No. 3 Year 2022 about Entrance (Entry Points) and Quarantine Place for Indonesian Travelers

On January 12th 2022, The COVID-19 Response Acceleration Task Force has issued the Decision Chairman Unit Duty Handling Covid-19 No. 3 Year 2022 about the latest updates of the Entrance (Entry Points) and Quarantine Place for Indonesian Travelers. This update regulation is **effective from January 12th 2022 until December 31st 2022** with the condition of future corrections in further notice if needed.

There are several points highlighted in this regulation:

- 1. Entrance for Indonesian Nationals (WNI) International Travelers with following entry points:
 - Airport: Soekarno Hatta, Banten; Juanda, East Java; and Sam Ratulangi, North Sulawesi.
 - Seaport: Batam, Riau Islands; Tanjung Pinang, Riau Island; and Nunuka, North Kalimantan.
 - Cross Border Posts: Aruk, West Kalimantan; Entikong, West Kalimantan; and Montaain, East Nusa Tenggara.
- 2. WNI International Travelers are required to follow the quarantine protocols by 7 x 24 hours period in The Centralized Quarantine Locations. The services include lodging, transportation, meals, medicine, Personal Protective Equipment, consumables and RT-PCR costs which are covered by the Government.
- 3. Centralized Quarantine Locations based on each entry points:
 - DKI Jakarta: Wisma Atlet Pademangan, RSDC Wisma Atlet Kemayoran, Nagrak Cilincing Flats, and Pasar Flats Manggarai Grass;
 - Surabaya, East Java: Surabaya Embarkation Hajj Dormitory, East Java Education Quality Assurance Institute (LPMP), Ministry of Education and Training Center (Badiklat) Religion Surabaya, Hotel Vini Vidi Vici, Hotel Grand Park Surabaya, Hotel Sahid, Hotel 88 Embong Malang, Hotel BeSS Mansion, Hotel Zest Jemursari, Hotel Bisanta Bidakara, Hotel Fave Hotel Rungkut, Hotel Life Style Hotel, Hotel Delta Sinar Mayang Sidoarjo, Hotel Zoom Jemursari, Hotel 88 Kedungsari, Hotel 88 Embong Kenongo, Hotel Pop Station Kota, Hotel Pop Gubeng, and Hotel Cleo Jemursari;
 - Manado, North Sulawesi: Hajj Tuminting and Badiklat Dormitory Maumbi;
 - Batam, Riau Islands: BP Batam Flats, Government Flats Batam City, Putra Jaya Flats, Hajj Dormitory, and Pos Shelter Labor Placement and Protection Services Indonesia (P4TKI);
 - Tanjung Pinang, Riau Islands: A Safe House Tanjung Pinang Trauma Center (RTPC) and Badan Shelter Protection of Indonesian Migrant Workers (BP2MI);
 - Nunukan, North Kalimantan: Local Government Flats Nunukan;
 - Entikong, West Kalimantan: Goods Terminal Building International (TBI) Entikong, Indonesian Job Training Unit (ULKI), and the Port Health Office Building (KKP) Entikong;
 - Aruk, West Kalimantan: Personnel Agency Training Building Region (BKD), Sambas City Hajj Dormitory, Wisma Pos Lintas State Boundary (PLBN) Aruk, and Brimob Dormitory;
 - Motaain, East Nusa Tenggara: Flats Yonif RK 744/SYB; or
 - Other quarantine accommodation places determined by Head of the Regional Covid-19 Handling Task Force based on recommendations from the Handling Task Force COVID-19.
- 4. The Centralized Quarantine obligations are only intended for:
 - Indonesian Migrant Workers (PMI) who return to Indonesia to stay at least 14 (fourteen) days in Indonesia;
 - Students/Students who return to Indonesia after completing education or carrying out study assignments abroad;
 - Government Employees who return to Indonesia after carrying out official trips abroad; and
 - Indonesian representatives in international competitions or festivals.
- 5. Government Employees who are unwilling to quarantine in the Centralized Quarantine Locations are obligated to quarantine at the Quarantine Hotel centrally determined by the Covid-19 Handling Task Force National/Regional with self-funded or other legitimate financing sources.
