Summary of Indonesia's Export and Import in 2021

We would like to inform you of the summary by quarterly of the Indonesia exports and imports in 2021 according to the data from Statistics Indonesia (Badan Pusat Statistik/BPS) as follow:

1. Export

Q1 (January - March): An increase of value export by 17.11% or USD 48.90 billion compared to the same period in 2020, and non-oil and gas exports reached USD 46.25 billion or an increase of 17.14% at the largest in animal/vegetable fats and oils.

The European Union (EU) as export destinations contributed to the values of non-oil and gas exports with a total of USD 3.456,8 along with Italy contribution at 2.25%. By sector, the manufacturing industry increased 18.06%, and by the province of origin, West Java was the largest export producer, followed by East Java and Riau.

Q2 (April - June): An increase of export value by 34.78% or USD 102.87 billion, and non-oil and gas exports reached USD 97.06 billion or an increase of 34.06% which occurred at the largest in iron and steel.

The EU contributed at USD 1.44 billion, with Italy by 1.14%. By sector, manufacturing industry increased 33.45%, agricultural products 14.05%, mining, and others 41.21%. The largest export producer was West Java, followed by East Java and Riau.

Q3 (July - September): A decreased of value export by 3.84% or USD 20.60 billion, and non-oil and gas exports reached USD 19.67 billion or a decrease of 3.38% in animal/vegetable fats and oil. The manufacturing industry increased 35.40%, agricultural products 6.37%, mining and others by 76.29%. The EU contributed at USD 1.58 billion, with Italy by 1.27%. The largest export producer was West Java, followed by East Java and East Kalimantan.

Q4 (October - December): An increase of value export by 41.88% or USD 231.54 billion, and non-oil and gas exports reached 219.27 billion, increased of 41.52% in animal/vegetable fats and oil. The manufacturing industry increased 35.11%, agricultural products by 2.86%, and mining and other products by 92.15%.

The EU contributed at USD 1.71 billion, with Italy by 1.27%. West Java was the producer of the most significant export, followed by East Kalimantan and East Java.

2. Import

Q1 (January - March): An increase of import value at 26.55% or reached USD 16.79 compared to February 2021 with the most significant imports of iron and steel. The European Union (EU) as a non-oil and gas trading partner country amounted to USD 2.42 billion, with Italy at 1.23%. Indonesia's surplus was USD 1.57 billion.

Q2 (April - June): An increase of 21.03% compared to May 2021 with the most significant imports of mechanical equipment. The EU contributed USD 4.99 billion, with Italy at 1.15%. Indonesia's surplus was USD 1.32 billion.

Q3 (July - September): A decrease of imports by 2.67% or USD 16.23 billion compared to August 2021 with the decline of electrical machinery/equipment and parts imports. Meanwhile, there was an increase of mineral fuels at 8.90% compared to August 2021. The EU contributed USD 7.78 billion, with Italy at 1.11%. Indonesia's surplus was USD 4.37 billion.

Q4 (October - December): An increase of 10.51% or USD 21.36 billion compared to November 2021, with the most significant imports on machinery/mechanical appliances and parts. According to the Broad Economic Categories (BEC), the total of Indonesia imports in January– December 2021 increased USD 5.529,5 million (37.73%) for consumption goods, USD 44.174,2 million (42.80%) for intermediate goods, and USD 4.924,1 million (20.77%) for capital goods. Indonesia's surplus was USD 1.02 billion.

In summary, the value of Indonesia's exports in December 2021 reached USD 22.38 billion. Compared to December 2020, the export value increased by 35.30% with the majority exports in January - December 2021 from West Java with 14.62%, followed by East Kalimantan at 10.50% and East Java at 9.94%. While the value of Indonesia's imports from January-December 2021 increased 47.93% compared to December 2020 with the majority of imports from ASEAN with 17.17% and the European Union 6.43%
