Updates information of the Visa on Arrival (VoA) and No Quarantine Obligation for tourism visit to Bali starting on 7 March 2022

The Coordinating Minister for Maritime Affairs and Investment and the Governor of Bali has issued the new policies of the implementation of a trial for the foreign traveler (PPLN) to visit Bali with tourism visa; the Visa on Arrival (VoA) and not quarantine obligated starting on **Monday, March 7, 2022**. The enforcement of the no-quarantine policy for PPLN, only applies through the entrance to Bali, through air and sea travel.

The Visa on Arrival (VOA) the foreign traveler (PPLN) is only applicable to foreigners from 23 countries as below:

1. Australia
2. The United States of America
3. The United Kingdom

Furthermore, there are several points highlighted and need to be met for the foreign traveler (PPLN) as below:

- a. Foreigners need to complete their COVID vaccination/booster
- b. Foreigners are proven negative for a PCR Swab test before departure
- c. Foreigners have proof of a paid hotel reservation for a minimum of 4 (four) days in Bali.
- d. Foreigners need to take the PCR Swab test upon arrival. If the test result is negative, foreigners are allowed to visit all tourist destinations throughout Bali.
- e. On the third day, foreigners are obliged to take the PCR Swab test, and if the test result is negative, on the fourth day they are allowed to travel outside Bali.
- f. Foreigners must have health insurance to guarantees COVID-19 decease in accordance with the provisions and the revocation of the obligation to have a sponsor/guarantor for a Tourism e-Visa request.
- g. For elderly foreigners whose PCR swab test results are positive and have co-morbidities, they are required to immediately follow treatment at the hospital.
