The Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to March 14th, 2022

According to the press conference held by Secretariat of the President of the Republic of Indonesia on Monday, March 7th, 2022, the coordinating minister for Maritime Affairs and Investment, Luhut B. Pandjaitan announced about the extension regarding the regulations of the implementation of Emergency Community Activity Restriction (PPKM) in Java-Bali. The government decided to extend the PPKM Java-Bali from March 8th to March 14th 2022. However, the PPKM in Jabodetabek and Surabaya dropped to Level 2, while other regions were still at Level 3.

The extension is affirmed in the Instruction of the Minister of Home Affairs (Inmendagri) No. 15 Year 2022 on the Enactment of Restrictions on Community Activities Level 4, Level 3 and Level 2 Corona Virus Disease 2019 in Java and Bali. There are a number of changes in Inmendagri No. 15 Year 2022. The first change is that the number of regions with PPKM Level 3 status in Java-Bali has decreased from 108 regions to 84 regions. The same thing also happened with the status of the regions on PPKM Level 2 which decreased to 37 regions. Meanwhile, for regions that are in PPKM Level 4 status has not changed, which is 7 regions.

Therefore, there are several adjustments on the regulations of PPKM in Java-Bali, include:

1. The implementation of activities in the non-essential sector is applied to:
 - Level 3: a maximum of 50% Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.
 - Level 2: a maximum of 75% Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.
 - Level 1: a maximum of 100% Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.

As DKI Jakarta is in the Level 2, hence Jakarta is implementing 75% WFO for non-essential sectors.
2. The implementations of non-quarantine hospitality have a maximum capacity of 75% of visitors and must use the PeduliLindungi application for screening.
3. The implementations of shopping activities are limited to operating hours until 21:00 local time with a maximum visitor capacity of 75% and must use the PeduliLindungi application.
4. The implementations of activities in shopping centers / malls / trading centers are opened with a maximum capacity of 75% until 21:00 local time.
5. The implementations of activities in places of worship are limited to a maximum of 75 percent capacity by implementing health protocols. Meanwhile, public facilities are allowed to be opened with a maximum capacity of 75% with health protocols.
6. Public transportation, mass transit, online taxis, rental vehicles, and aircraft are allowed with a maximum capacity of 75% with strict health protocols.

As emphasized before, the government still urges people to remain compliant with health protocols though the current positive cases of Covid-19 continue to decrease by always implementing 3M (wear a mask, washing hands, keep the distance and avoid the crowd) and 3T (testing, tracing, and treatment).
