The Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to March 21st, 2022

In accordance with the Instruction of the Minister of Home Affairs (Inmendagri) No. 16 Year 2022 concerning the Implementation of Restrictions to Community Activities Level 4, Level 3, and Level 2 Corona Virus Disease 2019 in Java and Bali, the government has again implemented the Java-Bali community activity restrictions (PPKM) starting **from March 15th until March 21st 2022**.

The extension is affirmed in the Inmendagri No. 16 Year 2022 on the Enactment of Restrictions on Community Activities Level 4, Level 3, and Level 2 Corona Virus Disease 2019 in Java and Bali. There are several changes in this regulation; an increase in the number of regions located at Level 2 from the original 37 regions to 55 regions. Meanwhile, there was a decrease in the number of regions at Level 3 from 84 regions to 66 regions. Level 4 regions have not changed from Inmendagri No. 15 Year 2022, which are still 7 regions. Likewise, with level 1, until now, there were no regions in Java and Bali that had entered Level 1.

Therefore, there are several adjustments to the regulations of PPKM in Java-Bali, including:

1. The implementation of activities in the non-essential sector is applied to:
 - Level 4: a maximum of 25% Work From Office (WFO) for vaccinated employees who are required to use the PeduliLindungi application at the workplace's entrance and exit;
 - Level 3: a maximum of 50% WFO for employees who have been vaccinated and are required to use the PeduliLindungi application at the workplace's entrance and exit; and
 - Level 2: a maximum of 75% (seventy five percent) of WFO for employees who have been vaccinated and are required to use the PeduliLindungi application at the entrance and exit of the workplace.

As DKI Jakarta is at Level 2, hence, Jakarta is implementing 75% WFO for non-essential sectors.
2. The implementation of non-quarantine hospitality has a maximum capacity of 75% of visitors and must use the PeduliLindungi application for screening.
3. The implementation of shopping activities is limited to operating hours until 21:00 local time with a maximum visitor capacity of 75% and must use the PeduliLindungi application.
4. The implementation of activities in shopping centers / malls / trading centers is open with a maximum capacity of 75% until 21:00 local time.
5. The implementation of activities in places of worship is limited to a maximum of 75% capacity by implementing health protocols. Meanwhile, public facilities are allowed to be opened with a maximum capacity of 75% with health protocols.
6. Public transportation, mass transit, online taxis, rental vehicles, and aircraft are allowed with a maximum capacity of 100 percent with strict health protocols.

To prevent additional cases of COVID-19, the government urges people to remain compliant with health protocols even though the current positive cases of COVID-19 continue to decrease by always implementing 3M (wear a mask, wash your hands, keep a distance and avoid the crowd) and 3T (testing, tracing, and treatment).
