The Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to April 4th, 2022

In following up on the directives of the President of the Republic of Indonesia, the Ministry of Home Affairs has issued an Instruction to the Minister of Home Affairs (Inmendagri) No. 18 Year 2022 to extend the Implementation of Community Activity Restrictions (PPKM) based on levels to suppress the transmission of the Corona Virus Disease (COVID-19) in the Java-Bali region for two weeks, from March 22nd to April 4th, 2022.

The government has again implemented the Java-Bali community activity restrictions (PPKM) with several changes regarding the number of regions implementing PPKM level 2 and 3. The number of regions implementing PPKM Level 2 increased from 37 to 55 regions, and then the area at Level 3 decreased, from 84 to 66 areas. Meanwhile, there are no regions in Java and Bali that have entered PPKM Level 1. The number of regions that have entered Level 4 has also not changed with the previous PPKM, as well as the regions have not changed. From now until an undetermined time, PPKM Java-Bali will be re-applied every 2 (two) weeks.

Therefore, there are several adjustments on the regulations of PPKM in Java-Bali, include:

- 1. The implementation of activities in the non-essential sector is applied to:
 - a. Level 1: a maximum of 100% Work From Office (WFO) for vaccinated employees who are required to use the PeduliLindungi application at the workplace's entrance and exit;
 - b. Level 2: a maximum of 75% WFO for employees who have been vaccinated and are required to use the PeduliLindungi application at the workplace's entrance and exit; and
 - c. Level 3: a maximum of 50% WFO for employees who have been vaccinated and are required to use the PeduliLindungi application at the entrance and exit of the workplace.
 - As DKI Jakarta is at Level 2, hence, Jakarta is implementing 75% WFO for non-essential sectors.
- The implementation of non-guarantine hospitality has a maximum capacity of 50% of visitors and must use the PeduliLindungi application for screening.
- The implementation of shopping activities is limited to operating hours until 21:00 local time with a maximum visitor capacity of 75% and must use the PeduliLindungi application.
- The implementations of activities in shopping centers / malls / trading centers / restaurants are open with a maximum capacity of 60% until 21:00 local time.
- The implementation of activities in places of worship and public facilities are limited to a maximum of 50% capacity by implementing health protocols.
- Public transportation, mass transit, online taxis, and rental vehicles are allowed with a maximum capacity of 75%, meanwhile aircraft has maximum capacity of 100% with strict health protocols.

To prevent the increasing cases of COVID-19, the government urges people to remain compliant with health protocols even though the current positive cases of COVID-19 continue to decrease by always implementing 3M (wear a mask, wash your hands, keep a distance and avoid the crowd) and 3T (testing, tracing, and treatment). The government also continues to increase weekly and daily tracing targets in each region.
