Updates on the extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to September 13, 2021

The Deputy for Economic Competitiveness Enforcement of the Coordinating Ministry of Economic Affairs, Ichsan Zulkarnaen conveyed the government's breakthrough in maintaining Indonesia's economic growth as the Job Creation Law (Omnibus Law) has been implementing. The complex restriction on investment is known to be one of the causes for the slow economic growth in Indonesia before. Thus, simplification of investment policies, particularly foreign investment, has become one of the government's focuses as an effort to develop Indonesia's economic growth in the future.

Through the press conference on September 6, 2021, the Coordinating Minister for Maritime Affairs and Investment, Luhut Pandjaitan announced the extension of PPKM Java-Bali for the next week, dated from September 7th until September 13th, 2021. It is reported that several improvements have occurred during the implementation of PPKM to this day, it can be seen by the reduction of cities/regencies in level 4, and the increase of cities/regencies in level 2. There are 13,049 cases of recovery cases so it reaches 3,850,000 cases, and the active case decreased by 9,248 or now to 146,271.

With this development, some adjustments will be carried out by the government, including:

- Dine in the Mall area can last for 60 minutes with a capacity of 50%
- The opening of 20 tourist attractions will be held in the PPKM Level 3 area by paying attention to the health protocols and the use of PeduliLindungi platform.

Furthermore, the minister also emphasized again the three main pillars in handling the Covid-19 pandemic in Indonesia, that is including:

- 1. The speed of vaccination, especially in areas that are centers of economic activity.
- 2. The applicability health protocols in all components of society by implementing 3M;
- Wear a mask (Memakai Masker)
- Washing hands (Mencuci Tangan)
- Keep the distance and avoid the crowd (Menjaga jarak dan Menjauhi kerumunan)
- 3. Massive testing, tracing, isolation, and treatment activities, including maintaining BOR, adding centralized isolation facilities, and ensuring the availability of medicines and oxygen supply.
