Updates on visa and stay permit based on the Permenkumham No. 34 Year 2021

On September 15th 2021, the Minister of Law and Human Rights, Yasonna H. Laoly signed the regulation of the Minister of Law and Human Rights (Permenkumham) No. 34 Year 2021 about Granting of Visa and Immigration Stay Permit for Period Handling of the Spread of Corona Virus Disease 2019 and National Economic Recovery. This regulation also replaces the previous the Minister of Law and Human Rights (Permenkumham) No. 27 Year 2021 concerning the Restrictions for Foreigners Entry into Indonesian Territory Implementation of Restrictions to Emergency Community Activities.

In regulation Permenkumham No. 34 Year 2021 Article 2 No. 1 and 2, states that a Foreigner holding a valid Visa or Residence Permit and valid can enter the Indonesian Territory through the Certain Immigration Checks after meeting the protocol health is determined by the ministry or agency that carry out the handling of COVID-19. The valid Visa or Stay Permit consists of:

- Service Visa (Visa Dinas);
- Diplomatic Visa (Visa Diplomatik);
- Visit Visa (Visa Kunjungan);
- Limited Residence Visa (Visa Tinggal Terbatas);
- Official Residence Permit (Izin Tinggal Dinas);
- Diplomatic Residence Permit (Izin Tinggal Diplomatik);
- Limited Stay Permit (Izin Tinggal Terbatas); and
- Permanent Residence Permit (Izin Tinggal Tetap)

Other than, Foreignerwith Visa or Residence Permits holders referred to in paragraph (2), the crew of the transportation means who come by using the means of transport, StrangerAsia-Pacific Economic Business Travel Cardholder Cooperation (KPP APEC), and traditional border crossers can enter the Indonesian Territory too.

Person in Charge of Transport Equipment coming from outside the Territory Indonesia is obliged to ensure that every Passenger brings:

- Valid COVID-19 negative
- RT-PCR results
- And evidence has received the full dose of the COVID-19 vaccine.

Obligation to bring negative COVID-19 RT-PCR results as referred to in paragraph (4) is excluded for transport, crew means entering the Indonesian Territory using a yacht. But, the obligation to have proof of having received the COVID-19 vaccine the complete dose as referred to in paragraph (4) excluded for Foreigners **under the age of 12 (twelve) years**. In addition, the Minister still temporarily suspends granting of Visa-free Visit and Visa on Arrival until the COVID-19 pandemic is declared over by the State Government of the Republic of Indonesia.
