Updates on the extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to October 4th, 2021

On September 20, 2021, the Coordinating Minister for Maritime Affairs and Investment, Luhut Pandjaitan announced the extension of PPKM Java-Bali dated from September 21st until October 4th, 2021.

It is reported that several improvements have occurred during the implementation of PPKM to this day, it can be seen that there are no more cities/regencies in level 4, and the increase of cities/regencies in level 3 or 2. There is a decrease in the number of daily cases to less than 2,000 cases per day, and the active cases less than 60,000. It is reported that the extension of PPKM which usually lasts for 1 week turns into 2 weeks. With this development, some adjustments will be carried out by the government, including:

- 1. Trial opening of the shopping center and mall for children under 12 years old with parental supervision (only in Jakarta, Bandung, DIY, Semarang, and Surabaya).
- 2. Non-essential offices in the PPKM level 3 area can conduct work from the office (WFO) with a maximum capacity of 25% for employees who have been vaccinated and the use of QR code in PeduliLindungi platform.

Furthermore, the minister also emphasized again the three main pillars in handling the Covid-19 pandemic in Indonesia, that is including:

- 1. The speed of vaccination, especially for elder people.
- 2. The applicability of health protocols in all components of society by implementing 3M;
- Wear a mask (Memakai Masker)
- Washing hands (Mencuci Tangan)
- Keep the distance and avoid the crowd (Menjaga Jarak dan Menjauhi Kerumunan)

3. Combining 3T (testing, tracing, and treatment) with centralized isolation place and the use of PeduliLindungi platform for early detection spread of cases.
