Decree of the Minister of Law and Human Rights No. M.HH-03.GR.01.05 Year 2021 on the Use of Visit Visa for the **Foreigners to Enter Indonesia Effective** 

The Minister of Law and Human Rights of the Republic of Indonesia (Kepmenkumham) released Decree No. M.HH-03.GR.01.05/2021 regarding types of activities foreigners are allowed to be granted visas during the period of handling the spread of Corona Virus Disease 2019 and national economic recovery. The Minister of Law and Human Rights, H.E Yasonna H. Laoly, stipulates tourism and filmmaking activities are allowed to enter Indonesia with Visit Visa (B211A) effective from October 13th, 2021.

This new regulation is the updates of the previous Kepmenkumham No. M.HH-02.GR.01.05/2021 that restricts several activities for foreigners in the country in accordance with handling Covid-19 and economic recovery to be adding tourism and filmmaking activities as a type of activities eligible for Visit Visa (B211A). There are four types of visas permitted for foreigners who want to enter Indonesia namely Diplomatic, Service, Limited, and Visit Visa.

However, there are two types of activities to be granted visas in Indonesia during the period of handling Covid-19 and national economic recovery as follows:

- Type of Visit Visa activities
  - a. B211A include: Tourism; Emergency and urgent work; Business talks; Filmmaking; Purchases of goods; Aid workers, medical, and food support; Government duties; Join transportation means in Indonesia; Visits for the development of the marina industry (yachters); and Government duties regarding Indonesia's Presidency in G20 or 144th Inter-Parliamentary Union (IPU).
  - b. B211B: Prospective foreign workers in the ability test at work.
- Type of Limited Stay Visa activities
  - a. Limited Stay Visa for Work Consists of Visa type C312 that include: Work as an expert; Join to work on ships, floating equipment, or installations operating in the territorial waters of the archipelago, territorial sea, or continental shelf, as well as the Indonesian Exclusive Economic Zone; Monitoring the quality of goods or production; Conduct inspections or audits on company branches in Indonesia; Serve after-sales; Install and repair machines; Do non-permanent work in the context of construction; Carry out activities in the context of making commercial films and having obtained permission from the authorized agency; Prospective foreign workers who will work in the framework of testing skills.
  - b. Limited Stay Visa Not for Work Consists of visa types;
    - C313: Make a foreign investment with a validity period of 1 year.
    - C314: Make a foreign investment with a validity period of 2 years.
    - C316: Attending education.
    - C317: Family unification

In addition, as emphasized by Coordinating Minister for Maritime Affairs and Investment, Luhut Binsar Pandjaitan in the latest press conference regarding the Extension of Emergency Community Activity Restriction (PPKM) Java-Bali, Indonesia is ready to reopen Bali for international arrival from several countries through Ngurah Rai Airport in October 14th, 2021.

The updates of the Ministry of Law and Human Rights of the Republic of Indonesia consists three new specified activities, which are:

- 1. Tourism and filmmaking as a type of Visit Visa activity with visa index B211A.
- Carry out activities in the context of making commercial films and have obtained permission from the competent authority as a type of Limited Stay Visa activity with visa index C312.
- 3. Attending education as a type of Limited Stay Visa activity with visa index C316.
