Update of Travel Requirements Information between Italy to Indonesia and Indonesia to Italy

Through this publication, we would like to inform you regarding the latest travel requirements for travel between Indonesia to Italy and Italy to Indonesia. Hopefully this information will assist you on your travel preparation from Indonesia to Italy and vice versa.

Travel Requirements from Italian Citizens Travelling to Indonesia

Based on the Circular Letter No. 18 Year 2021 Regarding International Travel Health Protocols During the 2019 Corona Virus Disease Pandemic by the Indonesian COVID-19 Task Force and Circular Letter No. 00081/PK/10/2021/64 by the Ministry of Foreign Affairs of Indonesia, here are several requirements needed to be fulfilled for Italian to travel to Indonesia:

COVID-19 Testing and Vaccination Certificate Requirements

Both foreigner and Indonesian passport holders entering Indonesia directly or transiting via other countries must provide a printed medical certificate of a negative COVID-19 PCR test, in which the sample taken must be a maximum 72 hours of departure time. This requirement also applies to infants and children. All passengers travelling also must take a COVID-19 RT-PCR test 1 x 24 hours after arrival in the Republic of Indonesia. Additionally, foreigners are required to present a COVID-19 vaccine certificate (printed or digital) confirming they have been fully vaccinated. Foreigners who do not meet these requirements will not be accepted for travel. Indonesia recognizes all COVID-19 vaccines if the vaccine is approved by the country in which it has been administered.

Required Forms

All passengers must download the PeduliLindungi Apps and fill the Electronic Health Alert Card (e-HAC). A completed online form must be presented to authorities on arrival in Jakarta.

Quarantine

Upon arrival in Indonesia, foreigners must proceed to a 4 x 24 hours mandatory hotel quarantine with the entire cost borne independently by them. Additionally, foreigners must also take another RT-PCR test 4 x 24 hours while undergoing quarantine before completing the mandatory quarantine period of 5 x 24 hours. Foreigners who test positive for COVID-19 on arrival or after the 5 x 24 hours of mandatory quarantine will be directed to a hospital for treatment. Hospital expenses for foreigners must bear the expenses themselves.

Travel Requirements for Italian Citizens Returning to Italy from Indonesia

Based on information gathered on the official website of the Ministry of Health of Italy, for Italian citizens returning to Italy from Indonesia, if you have stayed in/transited through Indonesia in the previous 14 days, you must:

- Undergo a molecular or antigenic swab carried out within 72 hours prior to entry into Italy and the result of which is negative.
- Complete the digital Passenger Locator Form, which replaces the previous self-declaration.
- Notify the prevention department of the health authority responsible for the area of your entry.
- Reach the final destination in Italy only by private transport.
- Undergo fiduciary isolation and health surveillance for 10 days.
- Undergo an additional molecular or antigenic swab at the end of the 10-day isolation period.

Travel Requirements for Indonesian Citizens Wanting to Travel to Italy

Unfortunately, as Indonesia right now is listed as "list E" country by the Italian Government, it is currently not possible to enter Italy for tourism reasons. However, entry into Italy from Indonesia is allowed only for specific reasons:

- Work.
- Health reasons.
- Study reasons.
- Absolute urgency.
- Return to one's domicile, home, or residence.
