## **INFORMATION** The Covid-19 Response Acceleration Task Force released Circular Letter No. 21 Year 2021

On 20<sup>th</sup> October 2021, the Covid-19 Response Acceleration Task Force released Circular Letter No. 21 Year 2021 regarding Domestic Travel Provisions During the Corona Virus Disease 2019 (Covid-19). It is reported that the domestic travel in the area Java-Bali Islands that requires Rapid Antigen Test has changed to 2 x 24 RT-PCR Test effective from **21**<sup>st</sup> **October 2021**.

As emphasized before, the Domestic Travelers (PPDN) must follow the provisions as below:

- 1. For travelers by air transportation mode going to Java-Bali Islands in areas with Level 4 and 3, must show vaccine card (min. first dose of vaccine) and negative results of 2 x 24 hours RT-PCR test whose sample was taken before departure.
- For travelers by sea and land transportation mode using private or public vehicles going to Java-Bali Islands in areas with Level 4 and 3, must show vaccine card (min. first dose of vaccine) and negative results of 2 x 24 hours RT-PCR test or negative result of 1 x 24 hours of Rapid Antigen Tests whose samples are taken before departure.
- 3. For travelers by land transportation mode using private or public vehicles routinely, and trains in one area / urban agglomeration area are excluded from the travel requirements as stipulated in number 2.

Travelers use logistics vehicles and other transportation of goods that travel domestically in the area of Java-Bali Islands apply the following provisions:

- 1. Must show a complete dose vaccine card and a certificate of negative Rapid Antigen Test results whose sample is taken within a maximum period of 14 x 24 hours before departure;
- 2. Must present the first dose of vaccine card and certificate of negative results Rapid Test Antigen whose sample is taken within a maximum period of 7 x 24 hours before departure, and if have not received any vaccination yet must present the certificate of negative results Rapid Test Antigen whose sample is taken within a maximum period 1 x 24 hours.
