Instruction of the Minister of Home Affairs (Inmendagri) No. 66 Year 2021 on Prevention and Countermeasures of Corona Virus Disease 2019 at Christmas 2021 and New Year 2022

The Minister of Home Affairs (Minister of Home Affairs) has issued the Minister of Home Affairs Instruction (Inmendagri) No. 66 Year 2021 regarding the Prevention and Countermeasures of Corona Virus Disease 2019 at Christmas 2021 and New Year 2022, which will be effective from December 24th, 2021 until January 2nd, 2022.

Through the instruction, the government has made some adjustments, including:

- 1. The acceleration of vaccine with a target of 70 percent for the first dose and 48.57 for the second dose of the total target, especially for the elderly and children aged 6-11 years old until the end of December 2021.
- 2. Tightening the flow of incoming travelers from abroad including Indonesian migrant workers, especially long-distance travelers using public transportation with mandatory: 2 doses of vaccines and must perform Rapid Antigen Test within a maximum period of 1 x 24 hours. Meanwhile, those who have not been vaccinated are prohibited.
- 3. Increase and maximize the use and enforcement of PeduliLindungi application in public places such as public facilities, entertainment facilities (shopping centers and restaurants), tourist attractions, and places of worship facilities.
- 4. Cultural arts and sports activities that can potentially cause the Covid-19 transmission is prohibited as well as other activities that have the potential to cause crowds.
- 5. Christmas and New Year celebration events in shopping centers and malls are eliminated, except for MSME exhibitions with the provision of operating hours at 09.00-22.00 local time.
- 6. Tourist attractions remain open with some tightening and local government supervision. The government will be the number of tourists is limited to 75 percent of the total capacity and will be implementing odd-even transport arrangements to visit priority tourist attractions.

Previously, the government planned to impose Restrictions on Community Activities (PPKM) level 3 throughout Indonesia from December 24th, 2021 to January 2nd, 2022. However, this decision was later overturned. With the release of this latest Instruction, the Ministry of Home Affairs number 62 of 2021 was revoked and declared invalid.
