Updates of the Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali, Effective from 5 April to 18 April 2022

The extension of the Community Activity Restrictions (PPKM) for the Java-Bali area was carried out once again. Following up on the President of the Republic of Indonesia's directive, the Ministry of Home Affairs has issued an Instruction to the Minister of Home Affairs (Inmendagri) No. 20 Year 2022 to implement the Level 3, Level 2, and Level 1 Corona Virus Disease 2019 (COVID-19) Community Activity Restrictions (PPKM) in Java and Bali, according to the criteria for the level of the pandemic situation based on the assessment, and to complete the implementation of PPKM and optimizes the COVID-19 Handling Post at the Village and Sub-District levels, from 5 to 18 April 2022.

The government has reintroduced the Java-Bali community activity restrictions (PPKM), with a few tweaks to the number of locations that are implementing PPKM levels 2 and 3. The number of regions adopting PPKM Level 2 increased from 37 to 55, while the number of places implementing Level 3 declined from 84 to 66. Meanwhile, no locations in Java or Bali have achieved PPKM Level 1. The number of areas that have entered Level 4 have not changed since the last PPKM, nor have the regions. PPKM Java-Bali will be reapplied every two weeks from now until an undetermined period. There is a change regarding the operating time of on-site eating/drinking activities in public places, which is until 22.00 local time.

As a result, various changes have been made to the PPKM rules in Java-Bali, including:

- 1. The implementation of activities in the non-essential sector is applied to:
  - Level 3: a maximum of 50 percent Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.
  - Level 2: a maximum of 75 percent Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.
  - Level 1: a maximum of 100 percent Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.

As DKI Jakarta is in the Level 2, hence Jakarta is implementing 75% WFO for non-essential sectors.

- 2. The implementation of non-quarantine hospitality has a maximum capacity of 50 percent of visitors and must use the PeduliLindungi application for screening.
- 3. The implementation of shopping activities is limited to operating hours until 21:00 local time with a maximum visitor capacity of 60 percent and must use the PeduliLindungi application.
- 4. The implementation of activities in shopping centers / malls / trading centers is opened with a maximum capacity of 60 percent until 21:00 local time.
- 5. The implementation of activities in places of worship is limited to a maximum of 75 percent capacity by implementing health protocols. Meanwhile, public facilities are allowed to be opened with a maximum capacity of 75 percent with health protocols.
- 6. Public transportation, mass transit, online taxis, rental vehicles, and aircraft are allowed with a maximum capacity of 75 percent with strict health protocols.

As emphasized before, the government still urges people to remain compliant with health protocols though the current positive cases of Covid-19 continue to decrease by always implementing 3M (wear a mask, washing hands, keep the distance and avoid the crowd) and 3T (testing, tracing, and treatment).
