## Updates of the Entry Points and the Health Protocol for the International Travelers during the Period of COVID-19, Effective from April 5th, 2022

On April 5<sup>th</sup>, 2022, the COVID-19 Response Acceleration Task Force has issued a Circular Letter (SE) No. 17 Year 2022 regarding the International Travel Health Protocol during the Corona Virus Disease Pandemic 2019 (COVID-19). In the circular letter, all international travelers (WNI and WNA) are now allowed to enter Indonesian territory through several new entry points and are not obligated to do an RT-PCR test upon arrival in Indonesia (if the international travelers are not detected to have symptoms of COVID-19 and have a body temperature of 37,5 degrees Celsius or below).

This update in the regulation is a part of the government's effort to handle the spread of COVID-19 in Indonesia, especially in preventing an increase in the transmission of the new variant of COVID-19, SARS-CoV-2 B.1.1.529, known as Omicron. With the enactment of Circular Letter (SE) No. 17 Year 2022, therefore the Circular Letter (SE) No. 15 Year 2022 and the Circular Letter (SE) No. 14 Year 2022 were **revoked and declared invalid**.

The several updates for international travelers (WNI and WNA) that arrive in Indonesia during the time after the enactment of this circular letter are as follows:

1. All international travelers (WNI and WNA) are allowed to enter Indonesian territory through the entry points for international travel as follows:
  - a. Airports:
    - Soekarno Hatta, Banten;
    - Juanda, East Java;
    - Ngurah Rai, Bali;
    - Hang Nadim, Riau Islands;
    - Raja Haji Fisabilillah, Riau Islands;
    - Sam Ratulangi, North Sulawesi;
    - Zainuddin Abdul Madjid, West Nusa Tenggara;
    - Kualanamu, North Sumatra;
    - Sultan Hasanuddin, South Sulawesi; and
    - Yogyakarta, Special Region of Yogyakarta.
  - b. Seaports:
    - Tanjung Benoa, Bali;
    - Batam, Riau Islands;
    - Tanjung Pinang, Riau Islands;
    - Bintan, Riau Islands;
    - Nunukan, North Kalimantan;
    - Tanjung Balai Karimun, Riau Islands; and
    - Dumai, Riau.
  - c. Cross Border Posts:
    - Aruk, West Kalimantan;
    - Entikong, West Kalimantan; and
    - Motaain, East Nusa Tenggara.
2. International travelers that have been confirmed positive for COVID-19 within a maximum of 30 days before departure and have been declared inactive in transmitting COVID-19 are not obligated to show a COVID-19 vaccination card or certificate and a negative RT-PCR result before the departure. On the other hand, they have to carry out a re-examination of RT-PCR upon arrival in Indonesia and attach a doctor's certificate or COVID-19 recovery certificate stating that the person concerned is no longer actively transmitting COVID-19.
3. Upon arrival in Indonesia, all international travelers are required to do a symptom check related to COVID-19 including checking body temperature and continue with the following conditions:
  - a. If they are not detected to have symptoms of COVID-19 and have a body temperature of 37,5 degrees Celsius or below, they **are not required** to do an RT-PCR Test.
  - b. Meanwhile, international travelers who are detected with symptoms of COVID-19 and have a body temperature above 37,5 degrees Celsius are obligated to do an RT-PCR test upon their arrival in Indonesia.
4. Furthermore, international travelers who are not required to do an RT-PCR test as referred to in point No. 3 and have received the second dose or third dose of vaccines are also not obligated to conduct quarantine and are allowed to continue their trip. Meanwhile, international travelers who only have received the first dose of vaccines are still obligated to conduct 5 (five) days of quarantine.

This regulation update will be evaluated and adjusted by the Indonesian Government in responding to the development of the new variant of the Omicron virus.
