Update the Use of Visa on Arrival (VoA) for Business Meeting and the Additional List of 86 Countries to Enter Indonesia

The Directorate General of Immigration issued the Circular Letter No. IMI/ 0700.GR.01.01 Year 2022 on 14 September 2022 and is effective from **15 September 2022**. The government officially adds 11 countries to the list of subjects for Visa on Arrival (VoA) including *Albania, Andorra, Chile, Ecuador, Iceland, Liechtenstein, Palestine, San Marino, Suriname, Uzbekistan, and Vatican*, which previously numbered 75 countries has now become **86 countries**.

The VoA previously only originally allowed foreigners to visit for the purpose of tourism, socio-cultural visits, or government duties, but due to the enactment of this Circular Letter No. IMI/ 0700.GR.01.01 Year 2022, the foreigners from 86 countries subject to VoA are allowed to carry out activities as follows:

- a. Tourist visits;
- b. Government duty visits;
- c. Business meeting visit
- d. Purchase of goods visits;
- e. Meeting visits
- f. Transits.

The requirements to apply for VoA as below:

1. Visiting the Bank Rakyat Indonesia (BRI) counter in the arrivals area at the air, land and sea entrances which can be found on Attachment 2 (Lampiran 2), Page 9 to Page 14 in the link [here](#)
2. Must attach:
 - Passport valid for at least 6 (six) months
 - Flight tickets leaving the territory of Indonesia
 - Proof of payment for Visa on Arrival (VoA)
 - Covid-19 vaccination certificate
3. Pay the Visa on Arrival (VoA) fee of IDR 500.000, which can be paid in USD (equivalent) or Rupiah.

With the enactment of this circular, the Director General of Immigration Circular Letter Number IMI-0650.GR.01.01 of 2022 concerning Ease of Immigration to Support Sustainable Tourism During the Corona Virus Pandemic Disease 2019 is **revoked and declared invalid**.
