INFORMATION Summary of G20 Summit Indonesia and the Leaders' Declaration

The G20 or Group of Twenty is an intergovernmental forum comprising 19 countries and the European Union with the aim to address major issues related to the global economy. The members of the G20 are Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkey, the United Kingdom, the United States, Spain, and the European Union. As each year the presidency invites guest countries, several international and regional organizations also participate, granting the forum an even broader representation. This year Indonesia held the Presidency of the G20 and lasted for one year from 1 December 2021 to 30 November 2022. As the G20 Presidency, Indonesia carried the spirit of recovery together with the theme "Recover Together, Recover Stronger".

Indonesian presidency focused on the 3 (three) priority sectors which were considered to be the keys to a strong and sustainable recovery namely; strengthening the global health architecture, digital transformation, and energy transition. Within the G20 there are 2 (two) pillars of discussion such as the financial pillar named "the Finance Track" and the "Sherpa Track" pillar which addresses economic issues, and non-financial development, and there is an engagement group.

The G20 Heads of State and Government Summit was held on 15-16 November 2022 in Bali, and was the pinnacle of the G20 process and intense work carried out within the meetings and working groups, with the event detailed agendas as follows:

At the final meeting, the Leaders agreed on a joint declaration with a total of 52 (fifty-two) points of the agreement contained in the G20 Bali Leaders Declaration. The contents of the declaration are the condemnation of war in Ukraine and the impact of war on global economic conditions and the formation of a pandemic fund that has collected USD 1.5 billion. Besides, the formation and operationalization of a resilience and sustainability trust (RST) under the International Monetary Fund (IMF) in the amount of USD 81.6 billion, the Energy Transition Mechanism, especially for Indonesia, obtained a commitment from the just energy transition partnership (JETP) of USD 20 billion. In addition, the Joint commitment at least 30% of the world's land and 30% of the world's oceans are also protected by 2030.
